ROCHESTER (US): Seven Prude's death. police officers involved in the suffocation death of Daniel Prude in Rochester, New York, were suspended Thursday by the city's mayor, who said she was misled for months about the circumstances of the fatal

Prude, 41, who was Black, died when he was taken off life support March 30.

That was seven days after officers who encountered him running naked through the street put a hood over his head to stop him from spitting, then held him down for about two minutes until he stopped breathing.

Rochester Mayor Lovely Warren announced the suspensions at a news conference amid outrage that city officials had previously kept quiet about

While denying a cover-up, Warren acknowledged that Prude was failed by the police department, our mental health care system, our society, and he was failed by me.

Hours after the announcement, a crowd of protesters unswayed by the suspensions demonstrated late into the night outside Rochester's police headquarters. Officers doused some protesters with a chemical spray and repeatedly fired an irritant into the crowd to drive activists away from metal barricades ringing the building.

Protesters protected themselves with umbrellas, dashed for cover, then returned to be fired on again.



2nd crew member, dead cows found in water after ship sank off Japan

TOKYO: Japanese rescuers found the second crew member and multiple dead cows Friday in waters where a livestock ship capsized and is believed to have sunk during stormy weather two days earlier, coast guard officials said. The man was found unconcious and floating face down about 120 kilometres northwest of Amami Oshima in the East China Sea, where rescuers have been looking for the Gulf Livestock 1 ship and its missing crew since it sent a distress signal early Wednesday.

The man, whose nationality and crew status is unknown. was taken to a hospital but later pronounced dead, said Takahiro

Yamada, a senior spokesman for the regional coast guard headquarters. He said rescuers also spotted dozens of cow carcasses floating in the area. So far, he said he was not aware of reports of any carcasses washing ashore the Japanese coast. The 11,947ton ship, its 43 crew and 5,800 cows left New Zealand in mid-August heading to Tangshan on China's eastern coast. The Filipino crew member, 45-yearold chief officer Edvardo Sareno, was rescued late Wednesday.

He told rescuers the ship stalled when an engine stopped, then capsized after being hit by a powerful broadside wave and sank.


